The Little Colorado River Weed Management Area

Anyone out there concerned about weeds? The Little Colorado River Plateau RC&D has a huge area to cover and weeds are part of the natural resources problem...such a problem! From weeds in your garden to cattle grazing and forage to incursions of noxious weeds on private, State and Federal and – all of these are concerns. The RC&D works with two Grants – one from the Arizona State Land Department; the other from the Eastern Arizona Counties RAC through the Apache-Sitgreaves NF's.

A Weed Management Area Committee has been formed and is working towards resolution of differences between the Federal and Arizona State Noxious Weed lists.

BMP's and the role of the private landowner in eradicating noxious weeds are also part of the critical mass.



Snapshots of other Little Colorado River Plateau RC&D projects.....

The RC&D's Watershed Coordinating Council has an ADEQ 319 WQIP Grant to improve water quality in the Coyote Creek Watershed, HUC 1502000103, spanning extreme eastern Arizona and western New Mexico. Land managers and owners have come together to create a Watershed Improvement Council, approve Best Management Practices and move rapidly forward into site specific projects on grazing lands



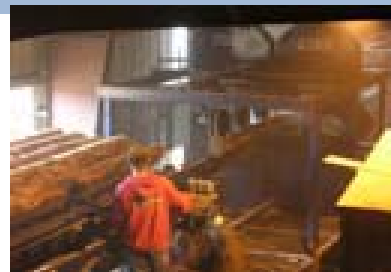
