### Gooding City Clean-Up!

The first annual Gooding City Wide Clean-Up took place on Saturday, October 2<sup>nd</sup>, 2010. Neighbors came together to help neighbors who were physically unable to do the work themselves. Overall 48 people volunteered for a total of 573 hours.

### Making Things Happen!

The Wood River RC&D Council works with local communities through our sponsors to develop and expand economic opportunities from our natural resources. The Wood River RC&D Council is actively engaged and involved in meeting America's need for renewable energy, as well as stimulating job creation and business retention in rural communities.



### Arbor Day Celebration!

The Gooding City's Tree Committee made three presentations to the City Council, did a tree inventory and held its first Arbor Day Celebration. Two trees were planted along with grass and shrubs. Gerry Bates (second from the right) is the Wood River RC&D's Urban Forester.



### Outreach Events!

Wood River RC&D participated in 14 workshops, one tour, two seminars, and seven outreach events. These events included Blaine, Camas, Gooding and Lincoln county fairs; Thousand Springs Festival; the Idaho Weed Conference and the Wood River RC&D's Tour & Steak Fry held at the Richfield City Park.

## Grants .....

- Idaho's Bounty Cooperative – received \$31,000 USDA, RBS grant to purchase a truck and freezer unit.
- \$15,000 USDA, RBEG grant to hire a grant writer.
- Awarded 3 USDA Value Added Agricultural Producer's grants for local agricultural producers for a total of \$198,852.
- \$10,000 grant to hire EnSave to do agricultural energy evaluations.
- \$47,160 in ISDA grants for weed eradication.
- \$55,000 in IDL fuels reduction grants.
- Lincoln County Veteran's Memorial - \$1,500 Idaho Community Foundation grant.



## South Fork of the Boise River Fuels Reduction Plan –

This project reduced 25 acres of hazardous fuels on private property in Camas County.

## Southern Idaho Bio-Control –

Expanded from four to six county wide teams (Student Bug Crews) with six units of invasive weed species managed. Partners include BLM, USFS, SCDs, county weed districts (CWMAs) and local schools.
